## Dear Sir/Madam,

With reference to above said subject we have in receipt of your email through Communication module of listing center on dated 31<sup>st</sup> January, 2025 wherein you have observed for the discrepancies in shareholding pattern for the period 31<sup>st</sup> December, 2024. In this respect the proper reason in reduction of number of promoters is as under:-

**Discrepancy:** 1. The details of Master Garv N Machhar (PAN ZZZZZ9999Z), Promoter is not available in the selected quarter of the Promoter category of Apt Packaging Ltd. It was available in previous period/quarter Shareholding Pattern.

2. Number of promoters compared to previous quarter is less. Provide proper reason for reduction in number of promoters. If reclassification is not approved by exchange, submit revised shareholding pattern with correct number of promoters.

**Reason:-** During the quarter from 1<sup>st</sup> October, 2024 to 31<sup>st</sup> December, 2024 Master Garv N Machhar (PAN ZZZZZ9999Z) has completed his KYC as per SEBI Circular with RTA agent. Upon PAN based consolidation of his all folios clubbed under one head and the earlier holding under the name of Master Garv Machhar (PAN ZZZZZ9999Z) holding shares 1950 clubbed into Garv Machhar (PAN AJHPM4183A) holding shares 37050. So, the overall consolidated holding in the name of Mr. Garv Machhar is reflecting 39000 shares in the record of RTA agent which has been reported by the RTA agent to us at the end of the quarter 31<sup>st</sup> December, 2024 and same has been updated to BSE through XBRL file. Besides, the number of promoters also get reduced from earlier 44 promoters to 43 promoters due to above reasons. There being no need to file the revised share holding pattern as there is no change in the number of shares held by Mr. Garv Machhar.

Hence, you are requested to please take on record the same.
